PRODUCT AND MANUFACTURER

ABOUT THE MANUFACTURER

The basic product range of the HERZ brand is ball valves of various designs for non-aggressive media, such as water, air, steam, oil derivatives, gases, as well as safety and regulatory elements for central heating systems, water and gas installations. HERZ products are the result of our own development and technology, which is subject to European standards that define usability and testing methods.

PRODUCT DESCRIPTION

The declared products are HERZ ball valves with extended plastic T-handle (models 1 2201 XX and 1 2206 XX). This is a group of similar products that mainly differ in nominal diameter (DN15 to DN50), mass, and dimensions of individual components, while the basic materials, construction design, and functional properties remain the same.

2201 Series (nickel-plated brass body)

- 1 2201 41 – 1 2201 56: Ball valve with extended T-handle, PN25 – For heating, cooling, and water systems
- 1 2201 61 – 1 2201 76: Ball valve with extended T-handle and thermometer, PN 25 – For heating, cooling, and water systems with temperature monitoring.

2206 Series (dezincification-resistant brass body)

- 1 2206 41 – 1 2206 56: Ball valve with extended T-handle, PN25 – For heating, cooling, and potable water systems
- 1 2206 61 – 1 2206 76: Ball valve with extended T-handle and thermometer, PN25, For heating, cooling, and potable water systems with temperature monitoring

The 2201 series uses nickel-plated forged brass, while the 2206 series uses DZR brass for enhanced corrosion resistance in potable water applications.

Common technical characteristics of all products within the group:

- Full bore
- Nominal pressure: PN 25 (25 bar)

- Operating temperature range: –30 °C to +150 °C (water +0.5 °C to +110 °C, no steam)

- Media: water, fuel oil, lubricating oils, air, and other non-aggressive media

- Materials: brass (main body), reinforced plastic (handle), PTFE (seals), EPDM/NBR (O-rings), stainless steel (some components)

The main differences between the individual valves in the group are the percentage of brass by weight (approximately 86% for DN15 to 95% for DN50) and minor differences in the amounts of plastic and PTFE seals. These differences result in differences in environmental impacts of ≤10% for most primary input streams (brass, plastic, PTFE). The valve with the highest impact for most indicators is the DN50 model; therefore, it was selected as the worst representative for the statement of results.

MANUFACTURING AND PACKAGING (A1-A3)

The environmental impacts considered for the product stage cover the manufacturing of raw materials used in the production as well as packaging materials and other ancillary materials. Also, fuels used by machines, and handling of waste formed in the production processes at the manufacturing facilities are included in this stage. The study also considers the material losses occurring during the manufacturing processes as well as losses during electricity transmission.

A market-based approach is used in modelling the electricity mix utilized in the factory.

The valve is made of raw brass forged and metal processing in our company. The pieces are assembled with other valves components like handles, body, balls, fittings, spindle, screw, O-ring, sealant and nut. Main components are from brass, plastics, steel, PTFE and adhesive. The A2 distance one way is between 70 km to 450 km. The manufacturing process requires gas, We obtain electricity from the grid, where a large part of the electricity comes from nuclear power plants and hydroelectric power plants. A smaller part of the energy comes from solar power plants and thermal power plants. We have heating with wood chips on site. A local supplier 2km away produces wood chips from lower quality wood from surrounding forests. Approximately 45% of brass is waste during processing. We combine the transportation of brass waste with the supply of new brass from the same supplier. The brass waste is sent to recycling. The distance between manufacturing site and waste treatment facilities is around 450km. The wastewater treatment is also considered. A wooden pallet and packaging film are used as a packaging material for transporting the product from the factory. Pallets are returnable and reusable. Cardboard packaging is fully recyclable. In most cases, this is the responsibility of the retailer, as products are usually shipped to store shelves without packaging.

TRANSPORT AND INSTALLATION (A4-A5)

Transportation impacts occurred from final products delivery to construction site (A4) cover fuel direct exhaust emissions, environmental impacts of fuel production, as well as related infrastructure emissions.

Average distance of transportation from production plant to retailer's site is assumed as 400 km and the transportation method is assumed to be lorry. Vehicle capacity utilization volume factor is assumed to be 1 which means full load. In reality, it may vary but as role of transportation emissions in total results is small, the variety in load is assumed to be negligible. To be conservative, empty returns are included in this study as implemented through an average load factor in the Ecoinvent transport datapoints. Transportation does not cause losses as product is packaged properly. The installation procedure is given in the technical data of the product and requires minimal additional energy and materials (sealing material). Environmental impacts from installation into the building include generation of waste packaging materials (A5) and release of biogenic carbon dioxide from wood pallets. The impacts of material production, its processing and disposal as installation waste are also included.

PRODUCT USE AND MAINTENANCE (B1-B7)

This EPD does not cover the use stage of the product (modules B1–B7 are not declared).

Air, soil, and water impacts during the use phase have not been studied.

PRODUCT END OF LIFE (C1-C4, D)

The product itself can be quickly removed from the installation and, with minimal additional work, disassembled to the extent that the brass and plastic handle are separated (for Module C1 demolition: no energy needed to demolish/disassemble the product).

End-of-life stage (C1–C4 + D)

Assumed scenario for EU:

Brass: 60% recycling, 40% landfilled (source: Copper Alliance, 2021)

Steel: 100% landfilled as conservative assumption as quantity is too small to be recycled.

Plastic: 100% incineration as conservative assumption.

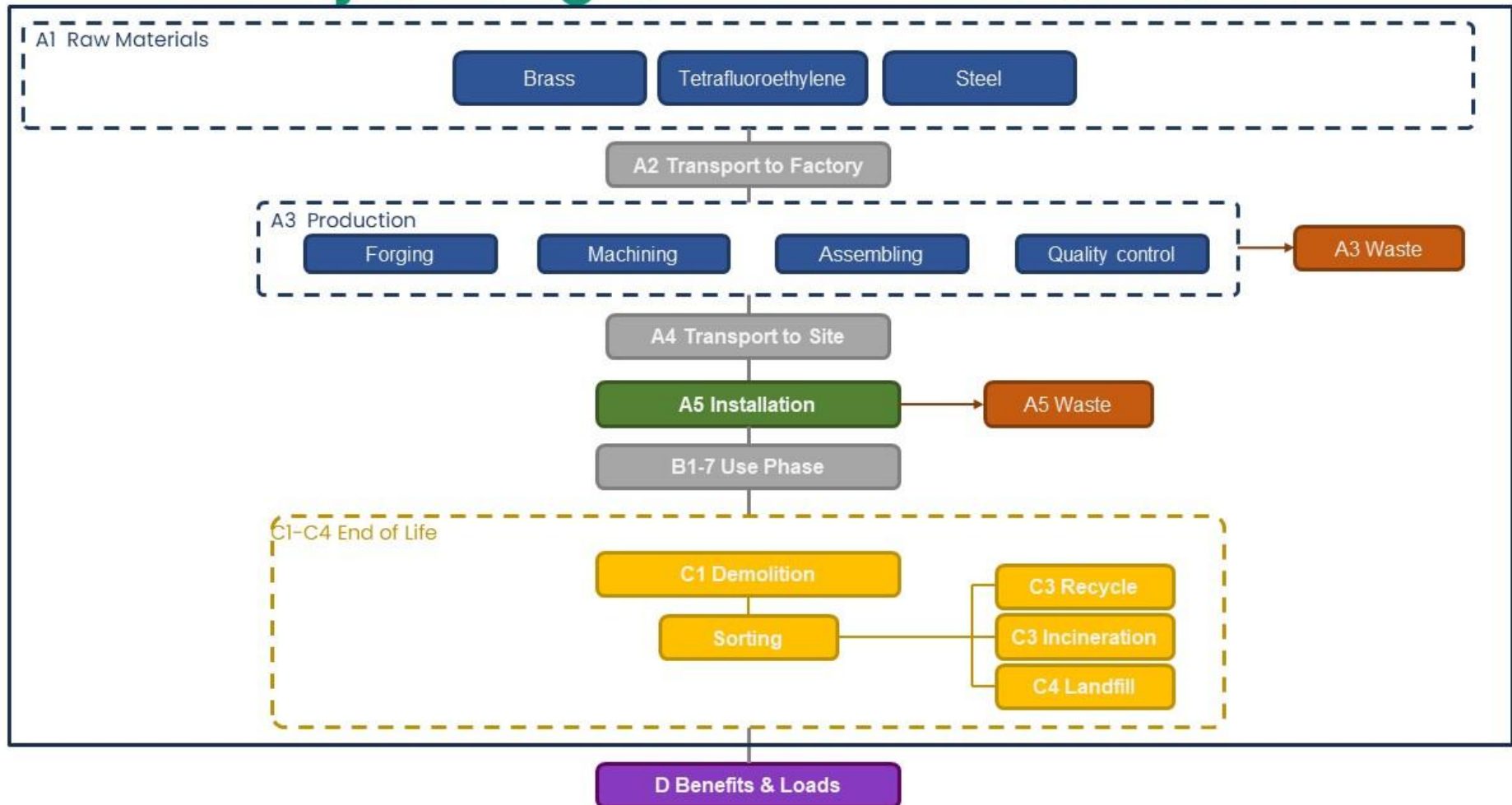
Benefits and loads are modelled in Module D. For the recycling scenario, benefits are the following:

- Recycled brass substitutes primary brass (ecoinvent dataset: market for brass, recycling input credit)
- Recycled plastic substitutes primary plastic (PP/PE mix)
- Energy from incineration substitutes average EU heat and electricity mix (substitution ratio according to EN 15804+A2)

Loads are modelled by impacts associated with producing secondary material/energy.

LIFE-CYCLE ASSESSMENT

CUT-OFF CRITERIA

The study does not exclude any modules or processes which are stated mandatory in the reference standard and the applied PCR. The study does not exclude any hazardous materials or substances. The study includes all major raw material and energy consumption. All inputs and outputs of the unit processes, for which data is available for, are included in the calculation. There is no neglected unit process more than 1% of total mass or energy flows. The module specific total neglected input and output flows also do not exceed 5% of energy usage or mass.

The production of capital equipment, construction activities, and infrastructure, maintenance and operation of capital equipment, personnel-related activities, energy and water use related to company management and sales activities are excluded.

VALIDATION OF DATA

Data collection for production, transport, and packaging was conducted using time and site-specific information, as defined in the general information section on page 1 and 2. Upstream process calculations rely on generic data as defined in the Bibliography section. Manufacturer-provided specific and generic data were used for the product's manufacturing stage. The analysis was performed in One Click LCA EPD Generator, with the 'Cut-Off, EN 15804+A2' allocation method, and characterization factors according to EN 15804:2012+A2:2019/AC:2021 and JRC EF 3.1.

ALLOCATION, ESTIMATES AND ASSUMPTIONS

Allocation is required if some material, energy, and waste data cannot be measured separately for the product under investigation. All allocations are done as per the reference standards and the applied PCR. In this study, allocation has been done in the following ways:

The DN50 valve 1 2201 46 (representative product) represents the worst case product. The variability of the primary data or emissions between products did not exceed 5% of the corresponding data (highest compared to best case for DN15). The primary data was averaged by calculating the weighted average of the raw material consumption, energy and waste generation of the products. This is the EPD for a group of similar products. Following types of the ball valves are included in the EPD and can be found in our production range on our website (Herz.eu):

Qualitative description of the products included: Full bore ball valves, extended plastic T-handle, differing mainly in nominal diameter (DN15–DN50) and corresponding mass.

Qualitative description of the functional areas: All products provide the same shut-off/filling/draining function for non-aggressive media under the same pressure/temperature conditions (PN 25, –30 °C to +150 °C).

Main similarities and differences: All products have the same materials, manufacturing technology and functional performance. The differences are quantitative (mass of brass and minor components), which causes up to 5% deviation in Global Warming Potential fossil kg CO₂e for A1-A3 Product stage.

LCA SOFTWARE AND BIBLIOGRAPHY

This EPD has been created using One Click LCA EPD Generator for EPD Hub V3 and EPD Process Certification v3.2.3. The LCA and EPD have been prepared according to the reference standards and ISO 14040/14044. The EPD Generator uses Ecoinvent v3.10.1/3.11 and One Click LCA databases as sources of environmental data. Allocation used in Ecoinvent 3.10.1/3.11 environmental data sources follow the methodology 'allocation, Cut-off, EN 15804+A2'.
